## INSURANCE:

Note that most companies today require that you buy your insurance within 1-2 weeks of making your deposit for the trip, in order to obtain maximum benefits.

UNDERSTANDINGS & RESPONSIBILITIES:

The price for the trip is \$10,430 per person, sharing a room/cabin throughout.

(Singles: Because of the nature of the private yacht, single participation is particularly expensive. The single supplement for the entire trip is \$8,010. If you are willing to share on the yacht, the single supplement that will guarantee you a private room elsewhere is \$1995.)

The price is based upon a minimum of 10 persons participating, and a maximum of 12. If fewer participate, the price may increase. If the price increases, you may withdraw from the trip without penalty or further obligation provided that you advise us in writing of your decision to withdraw within ten days of being advised of the increase. Prices include everything described in the published itinerary, including accommodations as named, meals as shown in brackets at the end of each day's description, sightseeing with local guides as detailed, all park and conservancy taxes, VAT and other government taxes, and hosting by EWT's Carol Mantey. Prices exclude anything not mentioned, including but not limited to your international air fare, air fare between Cuzco and Lima (which may be a part of your international air fare), the costs of obtaining requisite inoculations and documentation, meals not mentioned, most beverages and any items of a personal nature like books and maps.

\$200 of your \$500 deposit is immediately nonrefundable. Cancellations received prior to December 28, 2008, are subject to a \$350 per person penalty. After September 10, 2009, cancellations are subject to a \$500 per person penalty. EWT does not accept phoned cancellations. Only written (email is fine) cancellations are accepted. Final payment is due before January 12, 2010, and no funds are refundable after then.

Explorers World Travel, Inc., [the "Organizers"] accepts no responsibility for any damage, loss, accident, injury, delay or other irregularity which may be caused by the defect of any vehicle or the negligence or default of any company or person engaged in carrying out or performing any of the services involved in this safari.
