Children whose passport confirms he/she is less than 12 years or less than 17 years old at the conclusion of the safari qualify for the cost shown in green or blue, respectively, provided that they share a room/tent with at least one other full paying participant.

Prices described above include everything described in the itinerary on the website, including local flights and guiding throughout by a professionally-trained guide who will greet you on arrival and remain with you until you depart. Prices exclude anything not specifically mentioned, including but not limited to international air fare, tipping (your guide does not accept tips), the costs of obtaining requisite inoculations and documentation, some meals and most beverages and any items of a personal nature like souvenirs and personal gear.

After your deposit is received we will send you considerable preparatory information to help you get ready for the safari including information about visas, medications and coupons for discounted gear.

All payments you make to EWT are nonrefundable including the deposit. Final payment must be received earlier than 75 days before your arrival in Africa. Failure to make this deadline risks a cancellation default with no remuneration of the funds you had so far paid. Initial deposits are accepted by credit card without surcharge, but subsequent payments by credit card will be surcharged 4%.
