Children occupying a room without a full paying adult are charged full paying adult rates. (The cost for the 7-day Tanzania Pretour is \$4195 sharing; \$4775 as a single; \$3640 for children under 12 sharing with an adult; and \$3995 for children under 17 sharing with an adult. Local air fare is additional and changes frequently. At the time of this document the local air fare was an additional \$490 per person.) The prices are based on a minimum of 5 paying participants. The prices include everything exactly as described in the itinerary named "Justin's Dry Season Drama Safari," July 27 - August 3, 2018. These services include private transfers and transport, accommodations, most meals as indicated in brackets at the end of each day's description, all taxes and fees, two local flights (Samburu/Mara & Mara/Nairobi); and guiding throughout by Justin Stevens.
