The cost for the trip is \$6295 per each of two persons sharing a single room. The single supplement of \$1980 is additionally charged for those who solely occupy a room. Local air fare is additional and changes frequently. (At the time this document was written the local air fare was an additional \$1545 per person. Some of this might bundle into your international air fare. In fact, if you fly westbound through China for this program, the effective additional local air fare could be reduced by \$1000 per person.) The prices are based on a maximum of 12 paying participants. The prices include everything exactly as described in the itinerary named "Himalayan Kingdoms led by Kathleen Morgan," October 24 - November 4, 2018. These services include private transfers and transport, accommodations, meals as indicated in brackets at the end of each day's description, all taxes and fees, and private professional guiding. Anything not specifically mentioned in the itinerary is probably not included: Such items include but are not limited to international air fare, tipping, some meals, most beverages, the costs of obtaining requisite inoculations and documentation, and any items of a personal nature like souvenirs and gear.

Prices can change at any time. The only way to guarantee your price is to make a deposit, at which time the prices then prevailing are guaranteed. Your deposit is accepted by credit card without surcharge. Subsequent credit card payments are surcharged 4%. Final payment is due before July 26, 2018, and is nonrefundable.
