UNDERSTANDINGS & RESPONSIBILITIES:

I understand that the price is \$12,965 for each of two persons sharing a single room/tent for the 15-day "Jim's Classic South Africa/Botswana". Persons wishing to solely occupy a single room must pay an additional \$4,540. This high supplement reflects the single's cost aboard Rovos Rail. The supplement excluding Rovos Rail is \$2,350. Contact us directly for information on how to reserve as a single without including Rovos Rail. The price for the 6-day "Spring Wildlife Pretour" is \$1,990 sharing with a \$520 single supplement. The price for the 3-day "Victoria Falls Extension using the Royal Livingstone" is \$1,200 per person sharing with a \$670 single supplement. The price for the 3-day "Victoria Falls Extension using Tongabezi" is \$2,145 per person sharing with a \$610 single supplement.

The **prices cover** everything described in the itinerary, "2019 South Africa/Botswana Guided by Jim Heck," including accommodations as named, transport, meals as indicated in brackets at the end of each day's descriptions, all taxes, V.A.T. and training levies and guiding by Jim Heck. Jim joins the Wildflower Pretour but will not participate on either of the Victoria Falls' extensions. Prices include all air fare within Botswana, including charter air between the camps. But **prices exclude** all international air fare including the air fare required to fly between South Africa and Botswana. **Prices also exclude** anything not specifically mentioned in the descriptive itinerary including but not limited to tipping (Jim does not accept tips); the costs of obtaining requisite inoculations and other health precautions, some meals, most beverages and any items of a personal nature like souvenirs or gear.

A CURRENCY ADJUSTMENT IS POSSIBLE. This trip is costed in South African Rand at a current U.S. dollar exchange of 12.04. Should this exchange fluctuate significantly, EWT reserves the right to adjust the final invoice amount before the final payment date to reflect the correct exchange.

Your deposit is nonrefundable. Final payment is due before June 3, 2019, and no funds are refundable after those dates. Deposits are accepted by credit card without surcharge. Subsequent payments by credit card are surcharged 4%.
